The German Emissions Trading Authority (DEHSt) at the German Environment Agency publishes an annual up-to-date list of stationary installations subject to emissions trading in Germany. This is based on the same database used for the annual report published in mid-May on greenhouse gas emissions from installations subject to emissions trading in Germany ([current report](#)).

The operators send the electronic emissions report that documents the monitoring and calculation of emission volumes to DEHSt at the latest by 31 March of the year following the reporting year. The information in the emissions report is verified by independent, accredited verifiers who enter the aggregated emissions data directly into the so-called Verified Emissions Table (VET) in the European Union Registry also by 31 March. The operator must surrender a number of emission allowances by 30 April which correspond to the emissions volume from the installation in the previous year. The database used in DEHSt's report as well as for the list of installations will be compiled at the beginning of May after this deadline.

The evaluation of the allocation status is based on the free allocation of the previous year approved by 28 February of the current year by the European Commission. It includes the National Allocation Table (NAT) which lays down the basic free allocation for existing installations and the corrections to this basic allocation for individual installations approved by the European Commission by 28 February of the current year. These corrections may be allocation changes due to (partial) cessation or capacity reductions. In addition, the new market entrants' allocation amounts approved by the European Commission by 28 February are taken into account – these new participants may be new installations or capacity extensions of existing installations which started operation on or after 01/07/2011.

On 2 May 2019, 1870 installations were subject to emissions trading in Germany with respect to 2018. The attached list of installations presents these installations with the following information:

- ▶ 2008 to 2012 emissions – sum of the annual emissions from the emission reports (status of the verification: 28/02/2019) – the emissions from merged installations were also summed up retrospectively.
- ▶ 2013 to 2017 emissions – from the emission reports (status of the verification: 28/02/2019) – the emissions from merged installations were also summed up retrospectively.
- ▶ 2018 VET – emissions from the Union Registry on 02/05/2019.
- ▶ Allocation in the first trading period – sum of the 2005 to 2008 free allocation; the allocation of merged installations was also summed up retrospectively.
- ▶ Allocation in the second trading period – sum of the 2008 to 2012 free allocation; the allocation of merged installations was also summed up retrospectively.
- ▶ Allocation in the third trading period – current status of the 2013 to 2020 free allocations, approved by the Commission by 28/02/2019.
- ▶ The installation's main activity according to TEHG.
- ▶ Activity description.
