The German Emissions Trading Authority (DEHSt) at the German Environment Agency publishes an annual up-to-date list of stationary installations subject to emissions trading in Germany. This is based on the same database used for the annual report published in mid-June on greenhouse gas emissions from installations subject to emissions trading in Germany ([current report](#)).

Latest by 31/03 operators submit an emission report of the year following the reporting year to DEHSt. The emission report in which the monitoring and calculation of emission volumes is recorded, is verified by independent, accredited verifiers who must enter the aggregated emissions data by 31/03 into the so-called Verified Emissions Table (VET) in the European Union Registry. The operator then needs to surrender the same number of emission allowances equal to the emissions volume of the previous year by 30/04. The database used in DEHSt's report as well as for the list of installations will be compiled at the beginning of May after this deadline.

The evaluation of the allocation status is based on the free allocation of the previous year approved by the European Commission by 28/02 of the current year. It includes the National Allocation Table (NAT) which lays down the basic free allocation for incumbent installations and the corrections of this basic allocation for individual installations approved by the European Commission by 28/02 of the current year. In the 4th trading period adjustments of the free allocation due to activity level changes (EU2019/1842) or for the 3rd trading period due to (partial) cessation, capacity reductions or new market entrants and capacity increases in incumbent installations approved by the European Commission by 28/02 are taken into account.

On 2nd May 2022, 1,756 installations were subject to emissions trading in Germany with respect to 2021. There are also 24 installations that applied as small emitters. These installations will not receive free allocation and don't need to surrender emission allowances but must submit their emissions report.
